

## **Multiple Identity Cards – with different particulars**

Policy regarding clearance of Multiple Identity Cards with different particulars has been revised/updated. Now the applicants who are currently living abroad and having Multiple Identity Cards (where NADRA Registration Center are not operational) can also apply for clearance of their multiple cards as following:-

- a. Affidavit/declaration (specimen attached) (attested from Pakistan Mission).
- b. Surrendered Card Image (cut in 2 pieces) or FIR/Lost Report.
- c. Applicant will deposit the fee in NADRA online account. Account detail is as under:-

## **Cancellation of CNIC/NICOP**

In order to facilitate Pakistanis residing abroad, NADRA has recently started CNIC/NICOP cancellation through online web application. Now, at Pakistan Missions abroad, for the renunciation of nationality by the Pakistani expatriates, only fee of IMPASS may be charged and after the issuance of Renunciation Certificate, applicant may apply for cancellation of CNIC / NICOP by paying requisite fee through online system.

Before handing over the Renunciation Certificate to the Pakistani expatriate, it will be ensured that they have applied for cancellation of CNIC / NICOP through NADRA online system. NADRA online tracking ID / Receipt for cancellation with proof of online payment shall also be produced.
